NEW Program Announcement: Small Animal Primary and Urgent Care Internship 2023-2024.

The Veterinary Teaching Hospital at the University of Illinois at Urbana-Champaign is offering two 12-month post-DVM internships in small animal primary and urgent/convenient care. This program is designed to prepare the intern for successful integration into a busy full service veterinary practice or for a residency and eventual board certification in a myriad of specialties including Emergency and Critical Care, Surgery, and Small Animal Specialty.

The internship centers around premier full-service small animal primary and urgent care services housed in a state-of-the-art clinic on the Veterinary Medicine campus with surgical, dental, and imaging facilities. The intern veterinarian will rotate between Small Animal Primary Care and Urgent/Convenient Care services housed at Vet Med South Clinic in Urbana, IL. The interns will divide their time, spending approximately 50% of their service time with each.

The internship is designed to provide experience in all areas of clinical case work up and management, including routine surgical intervention, with faculty guidance. Interns work under the supervision of faculty members and have primary case responsibility on Primary Care and Urgent Care services during daytime, evening, and weekend receiving. The interns will work with fourth year veterinary students to provide wellness services to eligible members of the community, as well as Primary Care Service clients. Under general supervision of clinic faculty, the intern veterinarians will perform surgery on client-owned animals, and mentor fourth year veterinary students in that capacity. In addition to mentoring clinical-year students, the intern veterinarians will mentor the first- and second-year veterinary students during their clinical rotations and perform shelter staff educational training.

The interns must have graduated from an AVMA accredited college of veterinary medicine or have successfully completed the ECFVG or PAVE. Eligibility for Illinois licensure is required and must be obtained, as well as a valid DEA certification and an Illinois controlled substance license (cost will be reimbursed). Due to the nature of this position, the interns must obtain a valid Illinois driver's license and have a cell phone with texting capability.

Participants must be a citizen of the US, Canada, or Mexico, a US permanent resident (i.e. holding a "green card"), or other foreign national with employment authorization from US Citizenship and Immigration Services valid for and during the program's period of proposed training without our provision of assistance, support or sponsorship in obtaining employment authorization.

Upon successful completion of the program, an Internship Certificate is awarded.

The University of Illinois offers a complete benefits package. The salary for this position is \$32,243. Malpractice coverage is provided under the University of Illinois for services provided for university clients only. Parking is available for a monthly fee. The UIUC is an AA-EOE.
